STUDENT SPOTLIGHT



Reena Basher
Neytz HaChochma
Miami, FL

Reena Basher is a second grader at Neytz HaChochma, a private school for children with special needs in Miami. Reena, who was once very shy and unsure of herself, has emerged from her shell and is now a social butterfly. As her self-esteem continues to rise, Reena gains confidence to meet academic challenges.

In October of 1998, Reena was born with exposure to highly toxic levels of alcohol and substance abuse, and placed into the Basher's home as a foster child at the tender age of 9 days. Months into the placement, they were asked to become Reena's adoptive parents. There was nothing to think about — this little girl was already part of the family and the joy she brings the Bashers knows no bounds.

Over the years, Reena has faced many challenges. During infancy,

Reena battled with severe withdrawal from the substance abuse she was exposed to in the uterus. For the first 6 months of her life, Reena cried day and night, had convulsions and was diagnosed as a failure to thrive.

When Reena was young, she began to display inappropriate social behaviors, was not communicating effectively and had difficulty following directions. Later on, as she entered preschool, it was hard for Reena to concentrate on the tasks at hand or focus with minimal distractions. As a result, her frustration level increased and her self-esteem diminished.

With the financial help of Step Up For Students, Reena's education at Neytz HaChochma became possible. Since her enrollment on the scholarship two years ago, Reena is making excellent academic progress and is a happier child.

MORE THAN 4,000 RALLY IN TALLAHASSEE

More than 4,000 school choice supporters traveled from as far as Miami and Ft. Lauderdale to join the nation's largest school choice rally on April 12. Supporters were demanding passage of proposed legislation that would have expanded and protected school choice in Florida.

The rally—the fifth held annually by Step Up For Students—broke all previous attendance records. Wearing T-shirts that read “Many Faces, One Dream,” people representing nearly 35,000 scholarship students statewide expressed their desire for legislators to view school choice as a nonpartisan issue.

Gov. Charlie Crist delivered the keynote address, and was applauded for affirming his support for the state's Step Up For Students Scholarships and McKay scholarships for disabled students, as well as his dedication to a quality education for all Florida's children.

Rev. H.K. Matthews, a civil-rights leader

who worked with Dr. Martin Luther King, Jr., shared with the Rally participants how he sees the fight for school choice is an extension of his life's work.

State Sen. Alfred “Al” Lawson (D-Tallahassee) pledged his support for school choice and promised to continue representing his constituents' best interests.

Moving testimonies were given by Sharronda Perkins, the mother of a scholarship recipient from Tallahassee, and Alberto Garrido, a Hialeah student who has been on the scholarship program for the last five years. Both discussed how the Step Up For Students Scholarship Program has impacted their lives.

Thank you to everyone who assisted in this event. We could not do it without your support and we appreciate your continued encouragement as we continue our battle to protect and expand the Step Up For Students Scholarship Program.

LEGISLATIVE UPDATE

The 2007 Legislative Session ended as a disappointment to many families hoping for improvements to the Step Up For Students Scholarship Program. With your help, we worked hard to have House Bill 7145 filed and eventually passed in the House that would have raised the amount of the scholarship for middle and high school students, allowed certain foster children access to the program, and helped severely disabled children qualify for the McKay Scholarships for Students with Disabilities while receiving some educational services at home.



Due to your steadfast support of the program, we were successful in gaining bipartisan support for the bill from several new Democrat legislators in the House.

The Senate, however, had another bill that was vastly different from our preferred bill in the House. As has happened too often in the past, our preferred bill went down to the final hours with the House and Senate unable to reach an agreement. Many newspapers also reported that our bill was held up as the House tried to negotiate with the Senate to gain funding for a Florida Marlins baseball stadium.

We thank all of our parents and schools that contacted your legislators to tell them to support House Bill 7145. And now that the legislators are back in their districts, we encourage you to contact them again and share your disappointment in their failure to help the Step Up For Students Scholarship Program and also children with disabilities that need McKay Scholarships.

Next year we will be pushing for an increase in the scholarship amount and total number of scholarships we award needy families. Also, we must insist they pass our legislation early so we are not held hostage again for such things like a baseball stadium. Your voice is making a difference, even if it is small steps, you are making a difference. Keep up the good fight!

If your children meet the income standards to qualify for a Step Up For Students Scholarship, they may also qualify for Florida's health insurance program for uninsured children, Florida KidCare.

Florida KidCare is a program that includes Medicaid, MediKids, Healthy Kids and the Children's Medical Services Network.

Healthy Kids and KidCare is what every parent wants. And that's exactly what Healthy Kids and KidCare is about. It's quality, affordable insurance to help keep your children healthy. Good health insurance protects them when they're sick and even when they're not, with regular check-ups.

TO QUALIFY FOR FLORIDA KIDCARE, HERE ARE SOME OF THE REQUIREMENTS:

- Be under age 19
- Be a U.S. citizen or qualified non-citizen

COST:

- Monthly premiums depend on your household size and income. Most families pay \$15 or \$20 a month. Some families may pay more.
- You may have to pay small charges or co-payments for some services.
